Why are you running? "

I believe I can serve the citizens of St. Lucie County as a judge with integrity, fairness and impartiality. I believe my background illustrates my experience in the law as well as being hard working. I am dedicated to the beliefs of a highly moral judiciary system and believe I can serve as a ethical member of the judiciary provided I am elected.

Discuss experience and how it will benefit residents:

Licensed attorney in Florida for 21 years. I served as a: Florida Judicial Staff attorney-Trial court law clerk between 1993-1997. Served as Court Probate Counsel in Broward County between 1997-2002. As private attorney involved in court litigation with Homeowners Association, Wells Fargo bank, State Farm, L.A. Fitness, bankruptcy proceedings, Sallie , etc. I have a Bachelor's degree Accounting from St. John's University. I am a Graduate of State University of New York at Buffalo Law school in 1990. I earned a Master of Law degree in taxation from New York University Law School. St. Lucie County is a small community where citizens should be treated equally and with dignity and have their cases heard timely with a Judge that respects people with equality.

How long have you lived in St. Lucie County and how will that help you if you are elected:

I have been a permanent resident of the State of Florida over 21 years commencing with Broward County, then Palm Beach and subsequently, St. Lucie County. I have resided in both the City of Port St. Lucie and now at Spanish Lakes in Ft. Pierce, Florida. St. Lucie County is smaller than the other counties I have resided in. I have the chance to learn citizen composition and their prevalent issues. Citizens in St. Lucie County tend to represent a modest base of

people with common issues. I believe provided I am elected, and earn their votes, I will view each case with integrity and equality.

What makes me stand out from the other candidates?

I believe I am a modest human being with morals and ethics. I can serve my community with equality. I will treat citizens as human beings. Provided I am elected, I believe Judges should practice what they rule over. The reason I filed my candidacy in this seat was no Judge should act above the law, nor should a Judge expect special treatment different from other persons. Judges serve the citizens and should honor their profession and treat each day with dignity.

What is the largest judicial issue that you would fix if elected:

The Florida Judicial Code of Conduct Canon 7 prohibits Judicial candidates from making opinions, promises or pledges that may be deemed future rulings.

How will you make the courts more efficient, or is that not an issue facing the county?

The number of cases assigned to each Judge can determine how efficient and timely Judge's rulings are. The Judicial Code of Conduct has enacted rules on the timeliness of Court rulings that each Judge needs to abide by. However, when cases are divided amongst a greater number of Judiciary, in theory, cases should be decided quicker and provide efficiency in terms of public perception.

What legal case stands out...?

Again, discussing specific details of cases is not sanctioned since it can lead to a bias towards a particular issue which the Code of Judicial Conduct Prohibits.

I am diligent and hard working person that will care and treat their cases equally.
