The questions were constructed for each office to determine the candidate’s position on a number of issues that might come before him or her while in office, as well as, get insight into the candidate’s overall value system. The questions were designed to be answered by selecting a response – support, oppose, or undecided – that best represented the candidate’s position. Although written comments could be included, specific instructions sent with the survey stated that one of the responses had to be selected or the candidate would be considered as not answering that question. Also, the candidate’s completed questionnaire was to be returned by a specified date in order to be included. From the numerous questions in the candidate survey, a few were selected for this voter guide. The selection was made in order to provide as much distinction between candidates as possible.
